FORMER SUPERVISOR W. D. RUTHERFORD PASSES AWAY AT BANGOR

OROVILLE, May 23.—Last evening at his home in Bangor, William D. Rutherford, one of the best known and most respected residents of the state, breathed his last. The cause of death was pneumonia, from which he had suffered only a few days. The deceased was a young man in years, being but thirty-nine.

He leaves to mourn his death his wife and three children—Thelma, Helen and Robert; and aged mother, Mrs. Margaret J. Rutherford, of Wyandotte; a sister, Mrs. R. S. Powers, of this city, and six brothers—J. E., A. L., Eugene, F. M., R. C. and G. E. Rutherford.

Mr. Rutherford was the son of the late John T. Rutherford, one of the pioneer residents of Butte county. The family is one of the most prominent in the county, and Mr. Rutherford was one of its most prominent members.

In 1904 he was elected as the representative of the third supervisorial district on the board of supervisors, and for four years served the county in that capacity. For two successive years he was chairman of the board. He served his term with honor, and while the exigencies of politics resulted in his retirement, he took the matter gracefully, proving as strong in defeat as he had been in victory. During the whole four years of his term he gave the best of his ability to the office, and his conduct in public service was such that not even the suspicion of any ulterior motives conduct of public affairs ever attached itself to his name, but those of opposing political faith joined with the members of his party in acknowledging his honesty and his sincere desire to fill his office accordinging to his best light and with all theability of which he was possessed.

Mr. Rutherford, prior to his term in office as supervisor and subsequent to that time was a member of the county board of education. He was a member of the present county board, and up to the time he was stricken with his last illness had confidently expected to go to Stirling City, there to conduct the eighth grade examinations. At the time of his death he was the principal of the Bangor school. He was a member of Argonaut Parlor, No. 8, Native Sons of the Golden West, and of Oroville Lodge, No. 103, F. & A. M.
